Mark Shuster, of Shuster Advisory Group, concurred with staff's recommendation for the City Manager, Director of Human Resources, and Director of Finance to serve as the investment committee, and shared that the vast majority of their clients use a similar make-up for the investment committee. Shuster also recommended that on an annual basis Shuster Advisory Group and their Chief Investment Officer will brief the bargaining units with an overview of the investments, fees, interest rates, and overall general investment marketplace observations and trends. Staff indicated they would work with Shuster Advisory Group to coordinate this annually.
