# 1) Request from the "Beverly Hills Day" Centennial Committee

Marketing & Economic Sustainability Manager Roach provided a brief introduction of the City's Centennial Committees, including the "Beverly Hills Day" Committee (which will be developing a collection of Beverly Hills photos and images received from the community). Zale Richard Rubins and AJ Willmer spoke about their request seeking to use the CBHCCF's 501(c)3 certificate in order for the Beverly Hills Day Centennial Committee to be eligible for free website space from certain vendors, such as Google for example. The Committee can use the space to do outreach to the community, and allow for storage space for the community's photos and images. The Board discussed various details of the request such as release forms, copyright, advertising, website rights, and registration. Director Stone agreed to act as the liaison for the project. The Beverly Hills Day Centennial Committee's request was approved by the Board.

# 2) Regular Meeting Dates

Community Services Administrator Grable explained that as discussed at the previous meeting and per the by-laws, the meetings will be held on a bi-annual basis. The Board reached consensus to have meetings every six months in May and November.

Accounting Manager Rahban explained the Finance/Administrative Services Department handouts that provided detailed information regarding the donations received to date. The list included the individual donations for a total amount \$140,808 for the following projects and programs:

# 4) Draft of "Acknowledgement Letter" for Donations Received

Director Stone suggested adding the words "to the extent allowed by law" at the end of the first paragraph on the draft "acknowledgement letter" for donations that are received by the CBHCCF. The Board agreed that this letter would be signed by the CBHCCF Chairperson on behalf of the Foundation.

The Board agreed that two letters will be sent out for any and all donations: one from the Board signed by the current Chair, and the other from the City signed by the current Mayor.

#### 5) City Donation Guidelines

Assistant City Attorney Enriquez explained the City's guidelines for accepting gifts. Director Stone provided a draft Gift Acceptance Policy that will be reviewed by the City Attorney and City Manager and return to the Board for further discussion and approval.

Some of the topics that were discussed included: expanding the City Manager's authority to accept donations on the Foundation's behalf prior to its next meeting (the current CBHCCF By-Laws references an amount of up to \$50,000); accepting all unrestricted donations or gifts of any size; naming opportunities; establishing a list of "Approved Items" for any funds that may not be specifically targeted for a defined City program/project/etc.

#### 6) Draft Press Release

The Board provided various suggestions to modify the draft press release, which will be provided to the local news media, and placed on the City's website. It was also suggested to include information (and website address) regarding a list of other philanthropic opportunities (as well as inclusion of a website for the CBHCCF). Chair Bosse provided input on a quote for the press release.
