# Bike Beverly Hills: Let's Ride!

May is National Bike Month! It is a good time to brush up on bicycle safety rules and learn about different types of bikeways. Whether biking, walking, or driving, the most important thing is to look out for each other.

# As a cyclist:

- Ride in the same direction as traffic
- Be predictable and use hand signals when turning
- Wear a helmet (required if you're under 18!) and increase your visibility at night with a light
- Ride with confidence and stay safe by staying aware

# As a driver:

- Watch for bicyclists and pedestrians, especially when turning
- When getting out of the car use your right hand to open the door and turn your body to look for any oncoming bikes

- Give bicyclists space! The law requires at least 3 feet between vehicles and bikes when passing
- Put your phone down distractions increase reaction time

# Beverly Hills has different types of bikeways:

Sharrows are pavement markings that indicate a shared lane for bike and cars. Bicyclists may use the entire lane.



An on-street bike lane is space in the roadway designated for bikes only with striping or pavement markings.



A protected bike lane is separated from traffic by a physical barrier such as planters or posts.



If you're riding on a street without a bikeway, stay to the right if you're going slower than traffic.

# **Organic Waste Recycling**

### **Helping Fight Climate Change**

Senate Bill (SB) 1383, a Organics Waste Recycling law, went into effect on January 1, 2022. How does this affect Beverly Hills residents and businesses? Residents and businesses are required to separate and recycle organic waste.

# **Single-Family Residents**

Currently, single-family residents are subscribed to green waste container service for yard trimming material. Under SB 1383, this service is expanded to include additional food waste items, including food-soiled paper and organic material, in the residential green waste program. Residents should be now placing all food waste in the green bin.

# **Multi-Family Residents**

Multi-family properties with curbside pick-up and subscribed to green waste container service should be placing food waste, including foodsoiled paper and organic material, in the green bin. Multi-family properties collected by alley service will be contacted by a City representative or the City's hauler, Athens Service representative, by Summer of 2022 to arrange services.

#### Businesses

Businesses are required to separate and recycle their organic waste. Businesses can comply by subscribing to the organic waste service. Additionally, businesses will be contacted by a City or the City's hauler, Athens Service representative, by Spring of 2022 to arrange services.

# Drought Update California

With the severity of the drought growing, Governor Newsom released Executive Order N-7-22 on March 28th ordering Californians to limit their summer water use, potential banning of "non-functional turf" in the business sectors, and other serious conservation measures.

2022 has seen record dry months, low snowpack and sinking reservoirs levels. California water officials announced they were cutting State Water Project allocations from 15% to 5%, and warned residents to brace for a third year of drought.

#### Plant of the month

Spring is in the air and it is time for everyone to get outside and plant some beautiful plants from your local nursery. Leucospermum cordifolium 'Yellow Bird' (Nodding Pincushion) is an attractive, rounded, spreading, evergreen shrub with distinctively domeshaped yellow flower heads. Resembling pincushions, they bloom in abundance over spring and earlymidsummer. Leucospermums are a shrub that like to be planted in full sun. In your travels up and down Santa Monica Boulevard, the bright yellow flowers are hard to miss and consider adding Leucospermums to your plant pallet.
